

### DESCRIPTION

House no. 1:

Ground floor: large 35m² living room with wood-burning stove, small 14m² sitting room with wood-burning stove, 11m² study and large 30m² well-equipped kitchen with 2 cookers (one wood-burning cooker and one gas-burning cooker). Access to the garage (25m² - 2.15m wide door).

Between the ground floor and the first floor, intermediate level with a bathroom with bath and a toilet.

First floor: three bedrooms (12m<sup>2</sup> and 22m<sup>2</sup>), 2 of which have en suite bathrooms,

Second floor: 3 bedrooms (10, 11 and 12m²)? 8m² room with sink and access to the attic.

Heating system: 2 wood-burning stoves and 3 auxiliary electric heaters.

Sewage system: mains drainage.

The plumbing and electricity were completely renovated in 2011.

The parquet floor is solid wood.

House no. 2:

Ground floor: large  $50 \text{ m}^2$  room used as a workshop and storage area with a  $10 \text{ m}^2$  annexe and direct access to the garden.

First floor: 13m² bedroom, 11m² kitchen (with wood-burning cooker) and 6m² bathroom with toilet. Large room under the roof used as a workshop.

Second floor: two bedrooms (16m² and 10m²) each with a sink.

Not adjoining but 30 metres away, 548m<sup>2</sup> of land used as a vegetable garden and recreation area with a wooden shed.
